Proposed Disinterment and Re-interment of certain graves located
in "Old Section B" of the Tuscola Township Cemetery

PLEASE TAKE NOTICE THAT Tuscola Township intends to petition the Tuscola County Circuit Court to effectuate disinterment and re-interment of certain graves identified herein so the remains are not lost into the Cass River due to erosion.

PLEASE TAKE FURTHER NOTICE THAT the Township has been unable to locate any heirs, devisees, assigns and/or relatives of the decedents buried in the graves identified below, within the Tuscola Township Cemetery.

PLEASE TAKE FURTHER NOTICE THAT that the unknown heirs, devisees, assigns and/or family relatives may contact the undersigned with comments, concerns or questions regarding the proposed disinterment/reinternment of the identified deceased individuals listed below. Any such comments and concerns may be transmitted to Michelle Hicks, Tuscola Township Clerk, in writing and will be made part of the record in this matter.

PLEASE TAKE FURTHER NOTICE THAT Tuscola Township intends to disinter the following deceased individuals buried in certain graves located within "Old Section B Lot 81-A" and "Lot 86" of the Tuscola Township Cemetery and re-inter the remains into certain graves located "Old Cemetery, Block A, Lot 59," and "Old Section B, Lot 86" within the Tuscola Township Cemetery so they are not lost into the Cass River, as follows:

- Bethany Domick (1933-1960) to be re-interred into grave C-1;
- Emma Domick (1872-1950) to be re-interred into grave C-2;
- Baby Boy Domick (1943) to be re-interred into grave A-1;
- Lonnie A. Harmon (1932 – 1994) to be re-interred into grave D-1;
- Albert Domick (1868-1960) to be re-interred into grave D-2;
- Sarah Domick (1908-1994) to be re-interred into grave A-2;
- Albert Domick (1901-1974) to be re-interred into grave A-3;

The Township intends to disinter the remains of the below-named decedents from their graves located in Old Section B, Lot 86 of the Cemetery and reinter the remains into the following graves sites located in "Old Cemetery Block A, Lot 59," within the Tuscola Township Cemetery, as follows:

- Tom B. Munson (1849-1934) to be re-interred into grave B-1;
- Ada E. Munson (1853-1872) to be re-interred into grave B-2; and,
- Gertie G. Munson (1871-1879) to be re-interred into grave B-3.
