The Tuscola Township Budget Public Hearing will be held during the Special Meeting of the Tuscola Township Board on March 16, 2021 at 12:30 p.m. by electronic remote access, unless by the date of the Board Meeting it becomes lawful under state agency rules for an indoor in-person public meeting to be held. Electronic remote access, in accordance with Michigan law, will be implemented in response to COVID-19 social distancing requirements and limitations on the number of individuals in an indoor public gathering.

If in-person public meetings become a lawful option, then the meeting will be held both in person at the Tuscola Township Hall, 8561 Van Cleve Road, Vassar, MI 48768 and via electronic remote access.
