

**APPROVED MINUTES OF THE TUSCOLA TOWNSHIP BOARD OF TRUSTEES MEETING HELD ON  
MARCH 20, 2018, AT 1:00 P.M.**

**Hicks made a motion to approve the agenda. Barber seconded. Carried.**

**Verbeek made a motion to approve the budget work session minutes from the February 19, 2018, meeting. Fackler seconded. Carried.**

**Barber made a motion to approve the minutes from the February 20, 2018, board meeting. Verbeek seconded. Carried.**

Planning commission: there is one empty seat on the board.

Fackler has minutes from the VAAS meeting.

Rodammer arrived.

**Barber made a motion to approve resolution #2018-1 to opt out of allowing Medical Marihuana Facilities. Verbeek seconded. Carried. Roll Call: Yes - Hicks, Rodammer, Fackler, Barber, Verbeek.**

**Hicks made a motion to approve the 2018-19 fiscal year budget. Barber seconded. Carried. Roll Call: Yes - Verbeek, Rodammer, Fackler, Barber, Hicks.**

**Rodammer made a motion to approve the contract with Spicer to begin the renovations on the outside bathrooms. Verbeek seconded. Carried.**

**Rodammer made a motion for an additional \$500 pay for the clerk's position for the cemetery duties for the 2018-19 fiscal budget year. To be paid April 17, 2018. Verbeek seconded. Carried. Hicks abstained.**

**Rodammer made a motion to pave the following Township roads: Marilyn, Sohn (Atkins to Frankenmuth Rd.), and Cottrell (from M-15 to Waterman). Verbeek seconded. Motion was voted down.**

**Hicks made a motion to pave Marilyn Rd. and Sohn Rd. (from Atkins to Frankenmuth Rd.). Barber seconded. Carried.**

June 23rd will be the Paddle and Swim on the Cass River.

**Verbeek made a motion to pay the bills in the amount of \$50,597.84. Hicks seconded. Carried. Roll call: Yes- Fackler, Barber, Rodammer, Hicks, Verbeek.**

**Verbeek made a motion to move \$3625.04 from contingency into the following accounts:  
Auditing - \$50, Grave openings - \$3000, Insurance and Bonds - \$400, Pavilion Rental - \$175,  
Subcontractor - \$.04. Barber seconded. Carried.**
