Barber made a motion to approve the minutes from the February 17th Budget Work Session. Fackler seconded. Roll call: Yes- Fackler, Hicks, Barber, Verbeek, Rodammer. No- 0. Carried.

Verbeek made a motion to approve minutes from the March 17th regular meeting. Hicks seconded. Roll call: Yes- Hicks, Barber, Verbeek, Rodammer, Fackler. No- 0. Carried.

Fackler made a motion to approve minutes from the March 31st Public Budget Hearing. Barber seconded. Roll call: Yes- Barber, Verbeek, Hicks, Rodammer, Fackler. No- 0. Carried.

Barber made a motion to approve minutes from the March 31st Special meeting. Hicks seconded. Roll call: Yes- Rodammer, Verbeek, Fackler, Hicks, Barber. No- 0. Carried.

Hicks made a motion to approve the Intergovernmental Retail Water Service Agreement Between the City of Vassar and Tuscola Township with revisions discussed and noted and subject to review by attorney and supervisor before submission to City; authorize preparation of developers agreement to be circulated between the City of Vassar, Tuscola Township, and the developer with a capped amount for Tuscola Township @ \$66,000; and authorize the attorney drafting a water ordinance for enforcement within the Township. Hicks made a motion to adopt ordinance #2020-2, Tuscola Township Litter Ordinance. Fackler seconded. Roll call: Yes- Rodammer, Barber, Verbeek, Fackler, Hicks. No- 0. Carried.

Hicks made a motion to adopt ordinance #2020-3, Tuscola Township Vehicle Storage and Repair Ordinance, with the added exception to sub-paragraph 6 referring to restoration of old/classic vehicles, changing 2 days to 14 days in section IV, and adding a period at the end of 'operating farm' in Sub-paragraph, Section IV. Verbeek seconded. Roll call: Yes- Barber, Rodammer, Fackler, Verbeek, Hicks. No- 0. Carried.

Hicks made a motion to adopt ordinance #2020-4, Tuscola Township Dangerous Buildings Ordinance with the amendment of the fee schedule to \$100 (1st offense), \$200 (2nd offense), and \$500 (3rd offense or more). Verbeek seconded. Roll call: Yes- Fackler, Barber, Rodammer, Verbeek, Hicks. No- 0. Carried.

Verbeek made a motion to pay the bills in the amount of \$16,097.48. Hicks seconded. Roll call: Yes- Rodammer, Barber, Verbeek, Fackler, Hicks. No- 0. Carried.
