NOVEMBER 17<sup>TH</sup>, 2020 AT 1:00 P.M.**

**Hicks made a motion to approve the agenda. Verbeek seconded. Yes- Barber, Rodammer, Fackler, Verbeek, Hicks. No- 0. Carried.**

**Barber made a motion to approve minutes from the October 20<sup>th</sup> regular board meeting. Fackler seconded. Yes- Hicks, Verbeek, Rodammer, Fackler, Barber. No- 0. Carried.**

**Fackler made a motion to approve minutes from the October 26<sup>th</sup> Election Commission Public Accuracy Test. Hicks seconded. Yes- Hicks, Fackler. No- 0. Absent- Gohsman. Carried.**

Fackler will send a request to the Tuscola County Road Commission to get estimates on paving Jay Rd. (Cottrell to Vassar City limits), Atkins Rd. (Sohn to Frankenmuth), and the following roads located in the Village of Tuscola: 4<sup>th</sup> St. (Van Cleve to Church), Church St. (4<sup>th</sup> west), Elm St. (Van Cleve to Church), Main St. (Ormes to Loren), McCrump (Taylor to McPherson), McPherson (North St. to McCrump), North St. (Elm to 4<sup>th</sup>, 4<sup>th</sup> to Taylor, and Taylor to Van Cleve).

**Hicks made a motion to approve the PA116 for ZRS Land, LLC, sections 7 and 8. Verbeek seconded. Yes- Fackler, Barber, Rodammer, Verbeek, Hicks. No- 0. Carried.**

**Hicks made a motion to adopt Resolution #2020-11 for a partial termination of a Farmland Development Rights Agreement with a pre-existing structure for Larry Palmreuter. Fackler seconded. Yes- Barber, Verbeek, Rodammer, Fackler, Hicks. No- 0. Carried.**

**Verbeek made a motion to take \$20,000 out of Capital Improvements and put \$10,000 into Attorney and \$10,000 into Township Property and to take \$2896.02 out of Contingency and put it into Elections due to overages in the budget. Barber seconded. Yes- Hicks, Fackler, Rodammer, Barber, Verbeek. No- 0. Carried.**

**Verbeek made a motion to pay the bills in the amount of \$73,290.87. Barber seconded. Yes- Fackler, Rodammer, Hicks, Barber, Verbeek. No- 0. Carried.**
